FROM THE PRESIDENT

The ATA's 90th Annual Representative Assembly took place this past week-end in Edmonton and numerous issues were dealt with which will serve to provide Provincial Executive Council with direction for the upcoming year. The Saturday morning address by Minister Liepert was instrumental in galvanizing the resolve of the 450 teachers present, by motivating them to become significantly more politically active in light of this government's apparent disinterest in working collaboratively with the Association to deal with the issues facing the parties. The Government's move to delay any solution to the UFL, until a "Task Force" meets and presents findings sometime next Fall, was not well received. The 3% increase to the Education Budget along with Minister Liepert's comment that the combined \$220,000,000 surplus held by Boards could be used to enhance salary settlements to meet inflation, was met with abject derision. It is now very obvious that the upcoming year will be fraught with the potential for labour unrest unless teachers are willing to engage in a campaign of action to encourage this Government to change its attitude about K -12 education.

I will be sharing with you a great deal more information over the next few weeks and I would like to sincerely thank those schools who have already had me out to speak to their staffs – I am both gratified and pleased that many have already begun their letter writing campaign!
