Message to Teachers on the Progress of Ratification of the Memorandum of Agreement between the ATA and the Provincial Government

On Saturday, November 24, 450 delegates from across the province, including 25 representatives from Edmonton Catholic Local 54, attended an Emergency Representatives Assembly called to discuss the Unfunded Liability Agreement.

The one item of business on the ERA order paper was the following motion:

Be IT RESOLVED that the Memorandum of Agreement between the Government of Alberta and the Alberta Teachers' Association on the matter of the unfunded liability of the Teachers' Pension Plan and collective agreements, dated 2007 11 15, be accepted and recommended to bargaining units for ratification under General Bylaw 11(3).

The Memorandum provides for stabilization of the Teachers' Pension Plan with the Government of Alberta assuming the entire pre-1992 unfunded liability, a framework for five year collective agreements with salary increases, continuation of sunsetting provisions on working conditions and the advancement of professional practice.

The motion carried with over 90 percent of the delegates voting in favour.

During the lively question period and period of discussion and debate, it was determined that, although not perfect, the Memorandum was one which made an enormous contribution to the future of the teaching profession in Alberta and to ensuring the stabilization and continuation of the Teachers' Pension Fund. It maintains the government's commitment to the class size initiative; it creates an improved relationship with Alberta Education; allows the ATA to take over Practice Review; and it commits government to not making changes to legislation, regulation or policy that will affect the employment conditions under which teachers work. It will not change the membership status of any member or revise current collective bargaining rights of teachers under the Labor Relations Code. The Next Steps:

Your NSC has set aside the following two dates to conclude negotiations on our Local's Collective Agreement: November 29th and December 10th. After we have reached a Memorandum of Agreement with our Board, a General Meeting of the Bargaining Unit will be called to allow teachers to vote on **both** the proposed new CA between our teachers and our Board and the Memorandum between the ATA and the Government. This meeting of the Bargaining Unit has been scheduled to take place on **Jan 15 at 4:30 at the Mayfield Inn and Trade Centre.** The vote on the Local's new CA will be counted that night and results provided immediately. The vote on the Memorandum will follow the announcement of the CA vote and those ballots will be returned to Barnett House to be counted along with ballots from all Alberta teachers immediately after the Jan 31 deadline. *All 62 Locals must have reached an Agreement with their respective employers by the end of January before the Unfunded Liability Memorandum can be ratified.*

Please stay informed – the ATA website will continue to post new information related to this issue at www.teachers.ab.ca Posted items to look for are the letter from Premier Ed Stelmach to Frank Bruseker and documents related to the impact of the Memorandum on teacher salaries.
