The following excerpt was taken from the article "Alberta government, teachers and school boards in discussions about the future of teacher collective agreements" appearing on the Alberta Teachers' Association's home page: www.teachers.ab.ca:

Securing long-term labour peace, protecting education programs and enabling meaningful education transformation, all in difficult financial circumstances, have been key topics in ongoing discussions initiated by the Alberta government and involving representatives of the Alberta Teachers' Association (ATA) and the Alberta School Boards Association (ASBA). The Alberta government has asked teachers and boards to consider reopening and replacing those agreements with new ones extending to 2015.

The government, faced with managing a \$5 billion budget deficit, is asking teachers to forgo that increase, now estimated to be 4.3 per cent, in return for other benefits.

In return for teachers giving up their 4.3 per cent increase and accepting limited salary increases in subsequent years, significant and enforceable limits on the amount of time teachers will be responsible for instructing students would be implemented. As well, limits on the amount of additional time that teachers could be formally assigned to other duties beyond instruction would be established. Such restrictions on hours of work would be attractive to teachers as they would help rebalance teacher workloads, allowing additional time for lesson preparation, collaboration, professional development, community and parent outreach, and other board and government initiatives. Total assignable time, which includes instructional time, does not represent the entire workload of teachers.

A guarantee of a minimum number of professional learning days in the school year, the establishment of a standing government-ATA-ASBA consultation committee to address issues relating to the government's transformation agenda, a disputes resolution process for enforcing the agreement, maintenance of the class size initiative and a commitment to provide necessary funding to school boards are also in the mix.
